## MINUTES OF THE 1131st SPECIAL MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF KINGS POINT

The 1131<sup>st</sup> meeting of the Board of Trustees of the Village of Kings Point was called to order by Mayor Michael C. Kalnick at 8:35 a.m. June 22<sup>nd</sup>,2020, at the Village Hall of the Village of Kings Point, 32 Steppingstone Lane, Kings Point, New York 11024.

The Mayor stated that although the public hearings with regard to Bills 2C and 3 of 2020 had been closed at the Board's June 15, 2020, meeting, since more than 30 days had not past since the Nassau County Planning Commission received the bills for its comments, the Board could not vote on the adoption of those bills as local laws at that meeting. That 30-day period has now past, the Commission has not provided the Board with any comments, and the Board may now vote to adopt those bills as local law.

Upon motion by Trustee Sheldon Kwiat, seconded by Trustee Hooshang Nematzadeh, by resolution # 2020-53, the Board unanimously approved Bill 2C of 2020, a proposed local law amending Article IX, Architectural and Preliminary Site Review Board, of Chapter 161, Zoning, of the Code of the Village of Kings Point, to add a new section, §161-60, Waivers, as Local Law 1 of 2020. A copy of the Local Law is appended to these minutes and on file with the Village Clerk.

Upon motion by Trustee Kouros Torkan, seconded by Trustee Hooshang Nematzadeh, by resolution # **2020-54**, the Board unanimously approved **Bill 3 of 2020**, a proposed local law amending Section 1, § 140-1, definitions of Chapter 140, Swimming Pools, of the Code of the Village of Kings Point, to prohibit aboveground swimming pools, as Local Law 2 of 2020. A copy of the Local Law is appended to these minutes and is on file with the Village Clerk.

Mayor Michael C. Kalnick introduced **Bill 4**, of **2020**, a local law amending Article VIII, Off-Shore Structures, of Chapter 161, Zoning, of the Code of the Village of Kings Point. The Mayor stated that the adoption of the local law

would permit more feasible use of off-shore structures by Village residents without adversely impacting neighboring residents. Upon motion of Trustee Kouros Torkan, seconded by Trustee Hooshang Nematzadeh, by resolution # **2020-55**, the Board unanimously adopted the following resolution:

Mayor Michael C. Kalnick introduced **Bill 5**, **of 2020**, **a local law** amending § 161-48, Boat Storage, of Chapter 161, Zoning, of the Code of the Village of Kings Point by adding a new subsection G. The Mayor stated that the adoption of the local law, would eliminate the adverse visual impacts of boats being stored on residential properties when they are not typically used between November 14 and April 16. by adding a new subdivision 9. The Mayor stated that the adoption of the local law, would help provide more tranquil weekends and holidays for the residents. Upon motion of Trustee Sheldon Kwiat, seconded by Trustee Hooshang Nematzadeh, by resolution # 2020-57, the Board unanimously adopted the following resolution:
